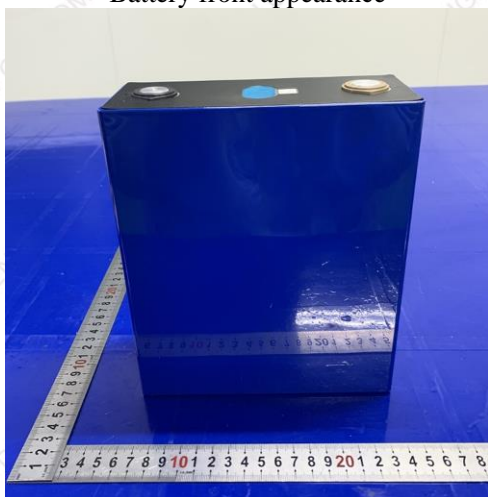

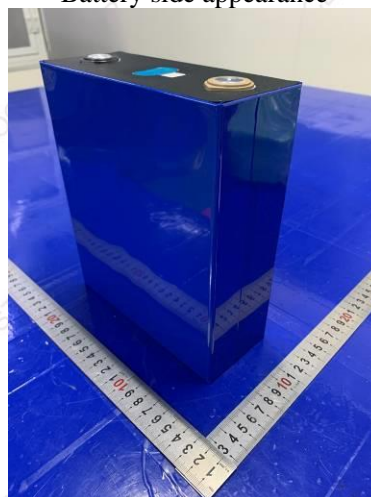

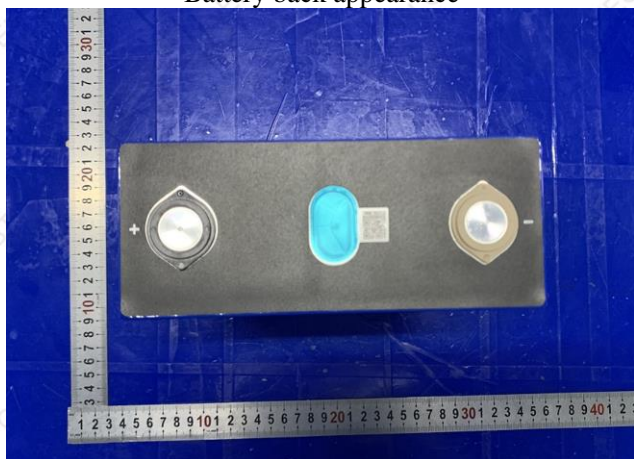
电池正面外观
